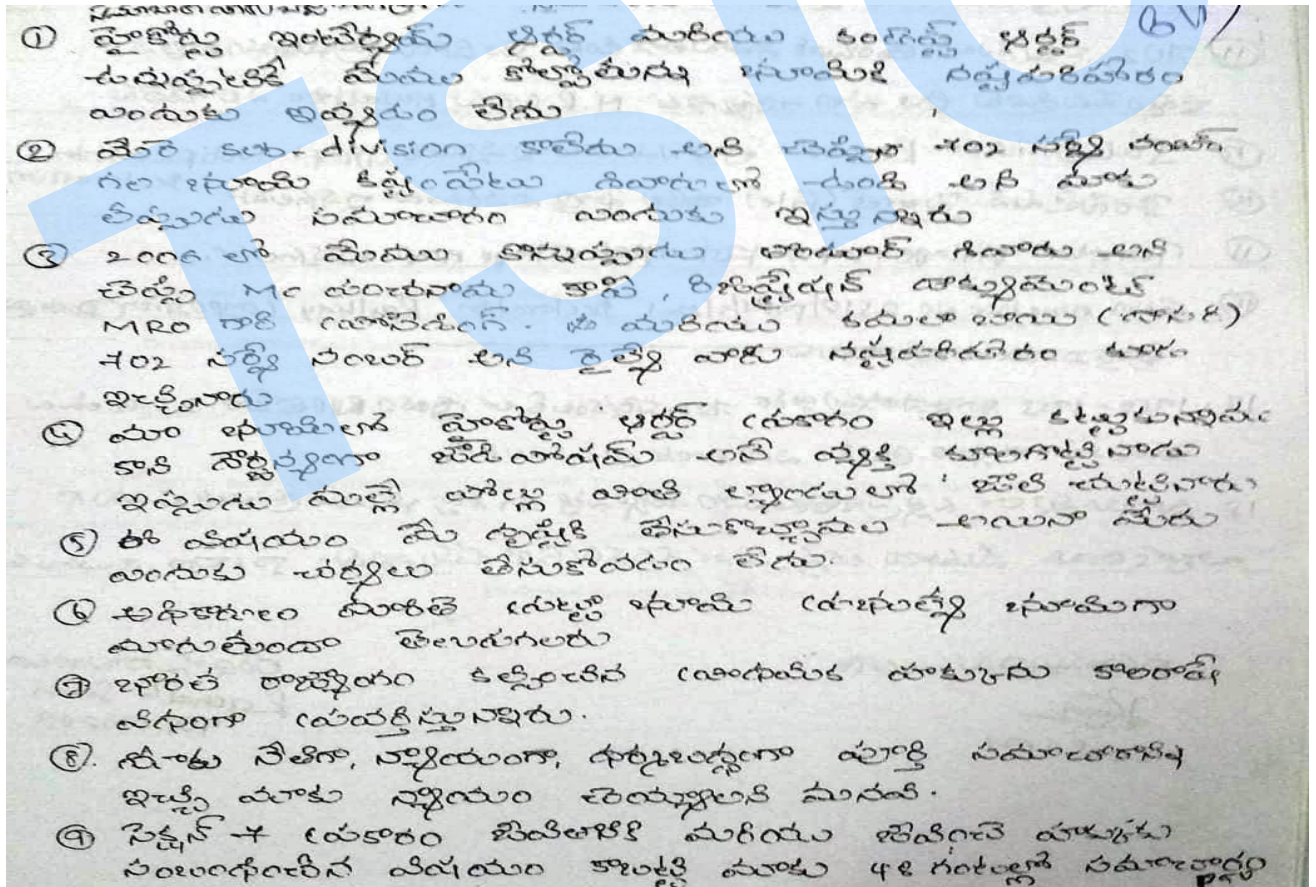

## Order

Smt. Racharla Vani, Mancherial District has filed a Complaint dated: 20-11-2021 which was received by this Commission on 23-11-2021 for not getting the information sought by him from the PIO / O/o the Tahsildar, Tandur Mandal, Mancherial District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 20-08-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.



and few more points.

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint was taken on file and Notices issued to both the parties for hearing on 06-07-2022 at 10.30 A.M.

The case is called on 06-07-2022. The complainant is present and filed her affidavit stating that the PIO has furnished part information. The APIO / Sri. N. Anjaiah, Senior Assistant is present on behalf of the PIO / Ms. D. Kavitha, Deputy Tahsildar, Tandur Mandal, Mancherial District is present and filed affidavit stating that notices were issued to the concerned parties including the complainant vide letter No: A5/730/2021 dated: 21-09-2021 informing that the Deputy Inspector of Survey, Bellampally Division, Deputy Inspector of Survey Land Records, Head Quarters, Mancherial District and the Mandal Surveyor, Tandur Mandal are going to form a team and a joint Survey will be done on 24-09-2021 and 25-09-2021 and requested the farmers of that area to be ready with their concerned documents. The APIO filed copies of the same before the Commission.

Heard both the parties and perused the material papers available on record. The complainant has stated that the PIO has not furnished the Survey report till now.

The Commission directs the PIO to furnish the latest Survey report to the complainant within One (1) Week from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the complaint is closed.
