Order

Sri G. Vijay Kumar, Ranga Reddy District has filed 2nd appeal dated: 22-11-2021 which was received by this Commission on 24-11-2021 for not getting the information sought by him from the PIO / O/o the Municipal Commissioner, Mancherial Municipality, Mancherial District and 1st Appellate Authority / O/o the Municipal Commissioner, Mancherial Municipality, Mancherial District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 06-08-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

- 5. నామినేషన్ పద్ధతిలో కేటాయించడానికి గల కారణాలు వివరిస్తూ పనుల కేటాయింపు అనుమతుల ప్రతులను జరపరుస్తూ మేము కోరిన రూపంలో సమాచారం ఇవ్వగలరు**

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 18-09-2021 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal was taken on file and Notices issued to both the parties for hearing on 01-06-2022 at 12:00 P.M.

The case is called on 16-09-2022. The appellant is absent. The PIO / Sri P. Madhukar, Municipal Engineer, O/o the Municipal Commissioner, Mancherial Municipality, Mancherial District is present and filed his affidavit stating that the information was furnished to the complainant vide letter No: Manager/PIO-1/173/RTI-2005/2022 dated: 13-09-2022 and filed copy of the same, but failed to submit the postal evidence before the Commission.

Heard the PIO parties and perused the material papers available on record. Upon not filing the documentary evidence of furnishing the information to the appellant, the Commission cannot accept the submissions of the PIO. The Commission took a serious view against the PIO for not furnishing the information to the complainant within the stipulated period of 30 days as per Section 7(1) of the RTI Act 2005. The Commission warns the PIO not to repeat such lapses in future and strictly adhere to the provisions of the RTI Act 2005.

The Commission directs the PIO to furnish the information to the appellant within One (1) Week from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.
