Order

Sri Anwar Pasha, Hyderabad has filed 2nd appeal dated: 29-11-2021 which was received by this Commission on 29-11-2021 for not getting the information sought by him from the PIO / Gram Panchayat Secretary, Khajapur Village, Shankarampet (R) Mandal, Medak District and 1st Appellate Authority / O/o the Mandal Praja Development Officer, Shankarampet (R) Mandal, Medak District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 22-10-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 25-11-2021 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal was taken on file and Notices issued to both the parties for hearing on 19-05-2022 and 14-07-2022 at 12:00 P.M.

The case is called on 14-07-2022. The appellant is absent. The PIO / Sri A. Prabhakar, Panchayat Secretary, Khajapur Village, Shankarampet (R) Mandal, Medak District is present and filed his affidavit stating that reply was given to the appellant vide letter dated: -05-2022 and filed copy of the reply, but failed to submit the postal evidence before the Commission.

The First Appellate Authority / Sri Ashok Kumar, I/c MPDO, Shankarampet (R) Mandal, Medak District is present and filed his affidavit stating that vide letter No: A1/RTI-2005/Khajapur/2021-22 dated: 03-12-2021 the PIO was directed to furnish the information to the appellant and filed copy of the same before the Commission.

Heard the PIO and the First Appellate Authority and perused the material paper available on record and observed that the PIO has taken charge on 30-11-2021 and the First Appellate Authority vide letter dated: 03-12-2021 directed to furnish the information to the appellant. The Commission is of the view that even after the direction of the First Appellate Authority, the PIO failed to furnish the information to the appellant.

Issue **Show Cause Notice** to the PIO / Sri A. Prabhakar, Panchayat Secretary, Khajapur Village, Shankarampet (R) Mandal, Medak District for not furnishing the information to the appellant within the stipulated period of 30 days as per Section 7(1) of RTI Act 2005 and even after the direction given by the First Appellate Authority. The action on the **Show Cause Notice** will be dealt separately.

The Commission directs the PIO to furnish the information to the appellant within Two (2) Weeks from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.
