## **Order**

Sri N. Chandra Prakash Reddy, Vikarabad District has filed 2<sup>nd</sup> appeal dated: 29-01-2022 which was received by this Commission on 03-02-2022 for not getting the information sought by him from the PIO / O/o the Tahsildar, Kosgi Mandal, Narayanpet District and 1<sup>st</sup> Appellate Authority / O/o the Revenue Divisional Officer, Narayanpet Division, Narayanpet District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 28-05-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

**Sub:-Requesting to furnish the information about Kosgi Revenue Village (Dist-Narayanapet) ROR(1b) for the year 1984-85 u/s 6(1) of RTI.**

kindly supply the above mentioned certified copies of one set in the format of soft copy to my above address through registered post.

If the above asking information is not available in your office kindly forward my application to the concerned public authority as per 6(3) of RTI act-2005.

I here by inform you that following formalities have been completed by me.

1. That I have been deposited the requisite fee of rs 20/- by way of IPO in favour of mandal revenue officer kcsgi

2 That I am citizen of India and I am asking the information as citizen.

3. am sure that I shall not allow/cause to use the information received in any case and under any circumstances, with any person in any manner which would be determinantal to the unity and sovereignty or against the interest of India.

\*I enclosed 1) one empty DVD for smart copy 2) I enclosed the IPO of No-02G 066584.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1<sup>st</sup> appeal dated: 22-06-2021 before the 1<sup>st</sup> Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1<sup>st</sup> Appellate Authority even after 30 days of filing his 1<sup>st</sup> appeal, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to take action against the PIO and 1<sup>st</sup> Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2<sup>nd</sup> appeal was taken on file and Notices issued to both the parties for hearing on 22-07-2022 at 10.30 A.M.

The case is called on 22-07-2022. The appellant is present and filed his affidavit stating that the PIO has not furnished the information. The PIO / Smt. B. Latha, Deputy Tahsildar, Kosgi Mandal, Narayanpet District is present and filed her affidavit stating that reply was given to the appellant vide letter no: A/237/2021 dated: 15-06-2021 and filed copy of the same before the Commission.

Heard both the parties and perused the material papers available on record. The appellant stated that he requires the complete village information for which the PIO submitted that the information sought would be huge & voluminous.

The Commission directs the PIO to allow the appellant for verification of records on a mutually fixed date and time by giving a prior intimation to the appellant and furnish the required information or give point wise reply to the appellant as sought through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.
