## **Order**

Sri K. Ramesh, Nizamabad District has filed 2<sup>nd</sup> appeal dated: 31-01-2022 which was received by this Commission on 03-02-2022 for not getting the information sought by him from the PIO / O/o the Tahsildar, Navipet Mandal, Nizamabad District and 1<sup>st</sup> Appellate Authority / O/o the Revenue Divisional Officer, Nizamabad Division, Nizamabad District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 12-10-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

అంబాపూర్ (జి) నివాసానికి సర్టిఫికేట్ 176A, 176B కు సంబంధించిన ఫోటో, 1 జి రికార్డుల మేరకు జిల్లా కార్యాలయం నుండి 2021 సెప్టెంబరు వరకు ఇవ్వాలని. జిల్లా కార్యాలయం 'అంబా ఫర్మ' నుండి చెల్లించాలని.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1<sup>st</sup> appeal dated: 08-12-2021 before the 1<sup>st</sup> Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1<sup>st</sup> Appellate Authority even after 30 days of filing his 1<sup>st</sup> appeal, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to take action against the PIO and 1<sup>st</sup> Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2<sup>nd</sup> appeal was taken on file and Notices issued to both the parties for hearing on 15-09-2022 at 10.30 A.M.

The case is called on 15-09-2022. The appellant is present and filed his affidavit stating that the PIO has not furnished the information. The APIO / Sri B. Devi Singh, Senior Assistant, O/o the Tahsildar, Navipet Mandal, Nizamabad District is present and filed his affidavit stating that the information was furnished to the appellant vide letter No: A/526/2021 dated: 27-10-2021 and filed copies of same before the Commission.

Sri S. Srinivas, Divisional Administrative Officer is present on behalf of the First Appellate Authority / Sri T. Ravi, Revenue Divisional Officer, Nizambad Division & District and filed his affidavit stating that vide letter No: A4/4680/2021 dated: 20-12-2021 & 03-01-2022 the appellant and the PIO were called for hearing and directed to furnish the information to the appellant.

Heard both the parties and perused the material papers available on record.

The appellant stated that the PIO has not furnished the copy of 1(B) register. The PIO stated that the same was furnished on 17-01-2022 and furnished another copy of the same to the appellant before the Commission. The Commission is of the view that the PIO has furnished the information to the appellant.

Since the information is furnished, the appeal is closed.
