## Order

Sri Mohammed Aleemuddin Sharfi Saifullah, Hyderabad has filed 2<sup>nd</sup> appeal dated: Nil which was received by this Commission on 03-02-2022 for not getting the information sought by him from the PIO / O/o the Deputy Commissioner, GHMC, Circle-9, Charminar Zone, Hyderabad and 1<sup>st</sup> Appellate Authority / O/o the Zonal Commissioner, Charminar Zone, Narqui Phool Bagh, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 08-10-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

attention to the sub & ref list. The details  
mentioned as follows  
1. I am enclosing here with a copy of  
letter addressed to and copy addressed to  
EECS NO 9 GHMC, DMCC of 2/CE/2  
GHMC let me know Action Dampit taken?  
2. Can you provide a copy of estimate  
with PLAN CC ROAD H/NO 20-4-368/5/2  
Khidmat Hyderabad  
Please give information under RTI  
in an on the subject.*

Stating that the appellant did not receive the information from the PIO, the appellant filed 1<sup>st</sup> appeal dated: 30-11-2021 before the 1<sup>st</sup> Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1<sup>st</sup> Appellate Authority even after 30 days of filing his 1<sup>st</sup> appeal, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to take action against the PIO and 1<sup>st</sup> Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2<sup>nd</sup> appeal was taken on file and Notices issued to both the parties for hearing on 18-08-2022 at 12.00 P.M.

The case is called on 18-08-2022. The appellant is absent. The PIO / Smt. G. Parwathalu, Deputy Executive Engineer, O/o the Deputy Commissioner, GHMC, Circle - 9, Charminar Zone, Hyderabad is present and filed his affidavit stating that the information was furnished to the appellant vide letter No: 994/EE/C9/CRZ/GHMC /2022 dated: 08-08-2022 and filed copy of the information furnished before the Commission.

Heard the PIO and perused the material papers available on record. The Commission took a serious view against the PIO for not furnishing the information to the complainant within the stipulated period of 30 days as per Section 7(1) of the RTI Act 2005. The Commission warns the PIO not to repeat such lapses in future and strictly adhere to the provisions of the RTI Act 2005.

Since the information is furnished, the appeal is closed.
