## Order

Sri Pallela Devaraju, Karimnagar District has filed 2<sup>nd</sup> appeal dated: 30-11-2021 which was received by this Commission on 03-12-2021 for not getting the information sought by him from the PIO / Gram Panchayat Secretary, Elagandal Village, Kotapalli Mandal, Karimnagar District and 1<sup>st</sup> Appellate Authority / O/o the District Panchayat Officer, Karimnagar District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 27-09-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

Stating that the appellant did not receive the information from the PIO, the appellant filed 1<sup>st</sup> appeal dated: 27-10-2021 before the 1<sup>st</sup> Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1<sup>st</sup> Appellate Authority even after 30 days of filing his 1<sup>st</sup> appeal, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to take action against the PIO and 1<sup>st</sup> Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2<sup>nd</sup> appeal was taken on file and Notices issued to both the parties for hearing on 22-07-2022 at 10.30 A.M.

The case is called on 22-07-2022. The appellant is absent. The PIO / Sri V. Nagaraju, Panchayat Secretary, Elagandla Village, Kotapalli Mandal, Kariminagar District is present and filed his affidavit stating that reply was given to the appellant vide letter No: E/RTI/111/2021 dated: 11-11-2021 the appellant was requested to pay the requisite fee and obtain the required information, since the appellant did not pay the requisite fee the information was not furnished. The PIO filed copies of the letter along with the postal acknowledgment before the Commission.

Heard the PIO and perused the material papers available on record.

The Commission directs the PIO to furnish the information to the appellant only after paying the requisite fee duly attesting through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.
