Order

Sri Ghanshyam Das Soni, Sirpur-Kagaznagar has filed 2nd appeal dated: 17-11-2021 which was received by this Commission on 03-12-2021 for not getting the information sought by him from the PIO / O/o the Municipal Commissioner, Kagaznagar Municipality, Komarambheem Asifabad District and 1st Appellate Authority / O/o the Municipal Commissioner, Kagaznagar Municipality, Komarambheem Asifabad District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 28-08-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

With reference to the subject and reference cited above I requests your good self to please provide me the details of Documents received along with copy of Applications received and also the copies of orders of Mutation done House No. 1 2 107 , 1 2 114/2, 1 15 222, 1 1 34 & 1 4 94, situated at Sirpur Kaghaznagar and oblige.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 01-10-2021 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal was taken on file and Notices issued to both the parties for hearing on 31-03-2022 and 06-07-2022.

The case is called on 06-07-2022. The appellant is absent. The APIO / Sri K. Bapu, Revenue Officer, O/o the Municipal Commissioner, Kagaznagar Municipality, Komaram Bheem Asifabad District is present and filed his affidavit stating that vide letter No: RTI/75/2021 dated: 17-09-2021 the appellant was informed that he is seeking 3rd party information and incase they give reasons in written as to why they are seeking 3rd party information, the said can be furnished. The PIO filed copy of the covering letter before the Commission.

Heard the APIO and perused the material papers available on record. The APIO further submitted that the copy of mutation proceeding and office note file was furnished to the appellant.

The Commission upholds the reply of the PIO and is of the view that the PIO has furnished the information to the appellant.

Since the information is furnished, the appeal is closed.
