Order

Sri R. Narayan Reddy, Karimnagar District has filed a Complaint dated: 30-11-2021 which was received by this Commission on 04-12-2021 for not getting the information sought by him from the PIO / Gram Panchayat Secretary, Chintakunta Village, Kothapally Mandal, Karimnagar District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 13-08-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint was taken on file and Notices issued to both the parties for hearing on 22-07-2022 at 10.30 A.M.

The case is called on 22-07-2022. The complainant is present and filed his affidavit stating that the PIO has not furnished the information. The PIO / Sri G. Lachaiyah, Panchayat Secretary, Chintakunta Village, Kothapalli Mandal, Karimnagar District is present and filed his affidavit stating that reply was given to the appellant on 09-02-2021, but failed to submit the documentary evidence of furnishing the information to the complainant before the Commission.

Heard both the parties and perused the material papers available on record. Upon not filing any documentary evidence of furnishing the information to the complainant, the Commission cannot accept the submission of the PIO. The PIO furnished information for point No: 3 before the Commission.

The Commission directs the PIO to furnish the balance information to the complainant duly attesting within One (1) week from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the complaint is closed.
