## Order

Sri Md. Jabeer, Adilabad District has filed 2<sup>nd</sup> appeal dated: 04-12-2021 which was received by this Commission on 07-12-2021 for not getting the information sought by him from the PIO / Secretary, O/o the Telangana State Legal Service Committee, Hyderabad and 1<sup>st</sup> Appellate Authority / O/o the Telangana State Legal Service Committee, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 16-08-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

Stating that the appellant did not receive the information from the PIO, the appellant filed 1<sup>st</sup> appeal dated: 11-09-2021 before the 1<sup>st</sup> Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1<sup>st</sup> Appellate Authority even after 30 days of filing his 1<sup>st</sup> appeal, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to take action against the PIO and 1<sup>st</sup> Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2<sup>nd</sup> appeal was taken on file and Notices issued to both the parties for hearing on 14-07-2022 at 10.30 A.M.

The case is called on 14-07-2022. The appellant is absent. The APIO / Smt. M. Kavitha, Section Officer, O/o the Secretary, Telangana State Legal Service Committee, Hyderabad is present and filed her affidavit stating that reply was given to the appellant vide letter ROC. No: 216/HCLSC/2019 dated: 27-08-2021 informed the appellant that the appellant has personally collected the papers and no material / papers are available with their office pertaining to the case in WP No: 2667/2020. The APIO filed copies of the same before the Commission.

Perused the material papers available on records. The APIO submitted that the appellant filed blank affidavits and applications.

The Commission advises the appellant to fill the affidavits and the applications along with all the required documents and visit the office of the PIO for further course of action.

In view of the above, the appeal is closed accordingly.
