

## **Order**

Sri Md. Jabeer, Adilabad District has filed 2<sup>nd</sup> appeal dated: 04-12-2021 which was received by this Commission on 07-12-2021 for not getting the information sought by him from the PIO / O/o the Registrar Judicial, High Court for the State of Telangana, Hyderabad and 1<sup>st</sup> Appellate Authority / O/o the Registrar General, High Court for the State of Telangana, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 26-07-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

Stating that the appellant did not receive the information from the PIO, the appellant filed 1<sup>st</sup> appeal dated: 04-10-2021 before the 1<sup>st</sup> Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1<sup>st</sup> Appellate Authority even after 30 days of filing his 1<sup>st</sup> appeal, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to take action against the PIO and 1<sup>st</sup> Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2<sup>nd</sup> appeal was taken on file and Notices issued to both the parties for hearing on 14-07-2022 at 10.30 A.M.

The case is called on 14-07-2022. The appellant is absent. Sri G. Naresh representative of Sri A. Kranthi Kumar Reddy, Advocate and Standing Counsel for the PIO / O/o the Registrar Judicial, High Court for the State of Telangana, Hyderabad is present and filed his affidavit stating that reply was given to the appellant vide letter ROC No: 269/PIO/Judl/2021 dated: 02-08-2021 informing that the appellant has not paid the court fee stamp / pay order/ postal order, hence the application cannot be considered and the same was returned and on filing 1<sup>st</sup> appeal dated: 04-10-2021 and vide letter Roc No: 2394/SO-2/2021 dated: 25-10-2021 the appellant was informed that there is a delay of 14 days in filing the Appeal under RTI Act 2005 and requested to file explanation for filing the appeal with a delay of 14 days on or before 05-11-2021 and since the appellant did not file any explanation the appeal was not registered. The representative of the PIO filed copies of the same before the Commission.

Perused the material papers available on record. The Commission is of the view that the appellant at the time of filing the 6(1) application dated: 26-07-2021 affixed the Ration Card details which shows that he falls under BPL category and is exempted from paying the court fee stamp. The PIO ought to have informed the status of the representation filed by the appellant on 24-02-2021.

The Commission directs the PIO to give a specific reply about the action taken against the representation dated: 24-02-2021 or inform the present status of the application to the appellant within Two (2) Weeks from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.
