Order

Sri M. Ruth Samson, Medchal Malkajgiri District has filed 2nd appeal dated: 03-02-2022 which was received by this Commission on 04-02-2022 for not getting the information sought by him from the PIO / O/o the Telangana State Women's Commission, 2nd Floor, Budha Bhavan, Secunderabad and 1st Appellate Authority / O/o the Telangana State Women's Commission, 2nd Floor, Budha Bhavan, Secunderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 04-08-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

With reference to the subject cited above, Mrs. Ruth Samson George / Mr. Samson George, Sy.No.199, Ward No.6, H.No: 12-87/19, Ambedkar Nagar, Old Peerzadiguda gutta, Medipalli, Medchal Malkajgiri District, Telangana State-500098, I request you to inform me about the status of my four letters reply dated: 15-04-2021 regarding Case No.78/2021, dtd.17-03-2021. So,

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 11-11-2021 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal was taken on file and Notices issued to both the parties for hearing on 25-08-2022 at 10.30 A.M.

The case is called on 25-08-2022. The appellant is present and filed her affidavit stating that the PIO has not furnished the information. The APIO / Smt. Sunitha Ch., O/o the Telangana State Womens Commission, 2nd Floor, Budha Bhavan, Secunderabad is present and filed her affidavit stating that the information is furnished to the appellant vide letter No: 08/RTI/B/TSCW/2021 dated: 25-08-2021 and filed copies of the information furnished before the Commission.

Heard the APIO and perused the material papers available on record. The appellant stated that she is not in receipt of the information, the APIO furnished copies of the information to the appellant before the Commission under acknowledgement of the appellant.

Since the information is furnished, the appeal is closed.
