Order

Smt. D. P. Shalini, Secunderabad has filed a Complaint dated: 09-12-2021 which was received by this Commission on 14-02-2021 for not getting the information sought by her from the PIO / O/o the Commissioner & Director of School Education, Saifabad, Hyderabad.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 12-08-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in her application annexed.

1. Guide lines to prepare syllabus for 1st class to 10th class
2. Guide lines to set question papers for 1st class to 10th class
3. Guide lines to evaluate 10th class question papers
4. What are the standard instructions issued to evaluators of answer sheets of 10th class while attending evaluation sessions?

Stating that the PIO has not furnished the required information even after 30 days of filing her application, she preferred this Complaint before the Commission requesting to arrange to furnish the information sought by her u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint was taken on file and Notices issued to both the parties for hearing on 06-07-2022 at 12:00 P.M.

The case is called on 06-07-2022. The complainant is absent. The PIO / Sri G. Parmeshwar, Assistant Director, O/o the Commissioner and Director of School Education, Hyderabad is present and filed his affidavit stating that vide letter No: 132/RTI/2021 dated: 06-09-2021 the application was transferred u/s 6(3) of RTI Act 2005 to the PIO / O/o the Director, State Council Of Education Research & Training, Fateh Maidan, Abids, Hyderabad and the PIO / O/o the Director, Government of Examinations, TS, Fateh Maidan, Abids, Hyderabad with a request to furnish the information to the complainant. The PIO filed copy of the covering letter before the Commission.

Heard the PIO and perused the material papers available on record.

The Commission directs the PIO / O/o the Director, State Council Of Education Research & Training, Fateh Maidan, Abids, Hyderabad and the PIO / O/o the Director, Government of Examinations, TS, Fateh Maidan, Abids, Hyderabad to give a specific reply / furnish point wise available information to the complainant within Two (2) Weeks from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the complaint is closed.
