Order

Sri Keshetti Venkateshwarlu, Hanumakonda District has filed a Complaint dated: 10-12-2021 which was received by this Commission on 16-12-2021 for not getting the information sought by him from the PIO / O/o the Commissioner & Director of School Education, Saifabad, Hyderabad.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 28-10-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint was taken on file and Notices issued to both the parties for hearing on 06-07-2022 at 12:00 P.M.

The case is called on 06-07-2022. The complainant is absent. The PIO / Sri G. Parmeshwar, Assistant Director, O/o the Commissioner and Director of School Education, Hyderabad is present and filed his affidavit stating that vide letter No: 643/RTI/2021 dated: 24-11-2021 the application was transferred u/s 6(3) of RTI Act 2005 to the PIO / O/o the District Educational Officer, Warangal District with a request to furnish the information to the complainant. The PIO filed copy of the covering letter before the Commission.

Heard the PIO and perused the material papers available on record and observed that the complainant filed 6(1) dated: 28-10-2021 seeking Biometric attendance of an employee working in MPPS, Narlapur from the year 2018 to Oct 2021. The Commission is of the view that instead of denying the information sought, the PIO blindly transferred the application on 24-11-2021 to the PIO / O/o the District Educational Officer, Warangal District with a request to furnish the information to the complainant. The Commission warns the PIO not to repeat such lapses in future and strictly adhere to the provisions of RTI Act 2005.

The Commission directs the PIO to give a specific reply to the complainant within One (1) Week from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the complaint is closed.
