Order

Sri G. Narsimulu, Kamareddy District has filed 2nd appeal dated: 17-12-2021 which was received by this Commission on 17-12-2021 for not getting the information sought by him from the PIO / O/o the District Collector, Kamareddy Collectorate, Kamareddy District and 1st Appellate Authority / O/o the District Collector, Kamareddy Collectorate, Kamareddy District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 24-06-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

కాండి తెలిపగలరు. ఎంతసేపంగా ఆ అధికారి వద్ద కాచి. ఇప్పటి వరకు తీయనచెప్పి
న చర్యలు.
3) నా ధరభాస్తును సంబంధిత అధికారుల వద్దకు పంపిస్తే వారికి సంబంధించి
మీ కార్యాలయం లో ఉన్న రికార్డుల అందజేయగలరు.
4) మీ కార్యాలయ నియమావళిని తెలుసుకుని అనుసరించి ఎక్కడో జరిగి
నా ధరభాస్తును పరిష్కరించాలి, వారికి సంబంధించిన సమాచారం ఇవ్వగలరు.
5) నా ధరభాస్తును పరిష్కరించాలి సంబంధిత అధికారులు ఆ విషయాలను
మీరు తెలియచేసిన మీ కార్యాలయం కార్యాలయ నియమావళిని అనుసరించి
చర్యలు తీసుకోవాలి.
6) నా ధరభాస్తును ఎంత వ్యవధి లోగా పరిష్కరించగలరో తెలిపగలరు.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 09-08-2021 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal was taken on file and Notices issued to both the parties for hearing on 15-07-2022 at 10.30 A.M.

The case is called on 15-07-2022. The appellant is absent. The APIO / Sri K. Sai Bhujang Rao, Superintendent is present and filed affidavit of the PIO / Sri K. Chandra Mohan, Additional Collector / District Revenue Officer, O/o the District Collector, Kamareddy District stating that vide letter No: H4/4491/2021 dated: 28-06-2021 the application was forwarded to the D – Section and H1 – Section Assistant of the same office with a request to furnish the information to the appellant and filed copy of the same before the Commission.

Heard the APIO and perused the material papers available on record and observed that the application was forwarded to the Deemed PIOs of D – Section and H1 – Section of the Collectorate and the deemed PIOs have failed to furnish the information to the appellant till the date of hearing.

The Commission directs the Deemed PIOs of D – Section and H1 – Section to furnish the information to the appellant within One (1) Week from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the complaint is closed.

Issue **Show Cause Notice** to the then Deemed PIO / Smt. G. Vidya, Superintendent D - Section, O/o the District Collector, Kamareddy District, present Deemed PIO / Sri K. Sai Bhujang Rao, Superintendent D - Section, O/o the District Collector, Kamareddy District and the Deemed PIO / Sri A. Ramulu, Superintendent H1 - Section, O/o the District Collector, Kamareddy District for furnishing the information to the appellant even after transferring the application as per Section 5(4) and 7(1) of the RTI Act 2005. The action on the **Show Cause Notice** will be dealt separately.
