Order

Sri Sultan Ahmed Bamahdi, Nizamabad District has filed 2nd appeal dated: 15-12-2021 which was received by this Commission on 20-12-2021 for not getting the information sought by him from the PIO / O/o the Tahsildar, Sadashivnagar Mandal, Kamareddy District and 1st Appellate Authority / O/o the Revenue Divisional Officer, Kamareddy Division, Kamareddy District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 22-10-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

2) Details of the {41} words of Copy of ROR proceedings information desired herein otherwise copy of the (within 500 words limits Registered Sale Deed/ Moka prescribed under Rule 3 of Panchnama etc, whereby RTI Rules 2a012] the land in Ac 0-155 Gts in Survey No. No. 57/ 800 /1/1 of village / shivar Padmajiwada has been transferred in favor of Mohammed Abdul Mujeeb.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 15-11-2021 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal was taken on file and Notices issued to both the parties for hearing on 15-07-2022 at 10.30 A.M.

The case is called on 15-07-2022. The appellant is absent. The PIO / Sri Ch. Sailoo, Deputy Tahsildar, Sadashivnaga Mandal, Kamareddy District is present and filed his affidavit stating that reply was given to the appellant vide letter No: A/481/2021 dated: 11-11-2021 and filed copy of the same before the Commission.

Heard the PIO and perused the material papers available on record. The PIO submitted that since the appellant did not mention the file No, proceeding no or the ROR copy, he could not furnish the complete information.

The Commission advises the appellant to mention the file No, proceeding no or the ROR copy so as to enable the PIO to furnish the information.

In view of the above, the appeal is closed.
