Order

Sri Muktar Ahmed, Adilabad District has filed 2nd appeal dated: 11-12-2021 which was received by this Commission on 20-12-2021 for not getting the information sought by him from the PIO / O/o the Tahsildar, Makloor Mandal, Nizamabad District and 1st Appellate Authority / O/o the Revenue Divisional Officer, Nizamabad Division, Nizamabad District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 30-08-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

1. Please provide me the entire mutation file granting of patta in favour of Sunkari Gangadhar from pattedar Late. Manzoor Ahmed.
2. Please provide me the Form-VII (Copy of Amendment Register) granted patta.
3. The names of the Tahsildar, Naib Tahsildar, Girdawar and VRO who granted the patta.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 29-09-2021 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal was taken on file and Notices issued to both the parties for hearing on 06-07-2022 at 10.30 A.M.

The case is called on 06-07-2022. The appellant is present and filed his affidavit stating that the PIO has not furnished the information. The PIO / Sri B. Bhaskar, Deputy Tahsildar, Makloor Mandal, Nizambad District is present and filed his affidavit stating that the information was furnished to the appellant vide letter No: D/576/2021 dated: 29-09-2021 and filed copy of the letter before the Commission.

Sri J. Suryam, Senior Assistant is present on behalf of the First Appellate Authority / Sri T. Ravi, Revenue Divisional Officer, Nizambad Division & District and filed his affidavit stating that vide letter No: A4/4139/2021 dated: 06-11-2021 the appellant was called for hearing on 17-11-2021.

Heard both the parties and perused the material papers available on records and observed that the appellant filed 6(1) application dated: 30-08-2021 seeking information on 3 points and the PIO vide letter dated: 29-09-2021 furnished the information and vide letter No: D/664/2021 dated: 22-11-2021 informed the appellant that the information sought is not traceable. The Commission is not satisfied with the contrary reply of the PIO. The PIO assured to rectify and furnish the information to the appellant.

The Commission directs the PIO to furnish the information to the appellant within Two (2) Weeks from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.
