Order

Sri Md. Feroz Khan, Kamareddy District has filed 2nd appeal dated: 11-12-2021 which was received by this Commission on 20-12-2021 for not getting the information sought by him from the PIO / O/o the Tahsildar, Gambhiraopet Mandal, Karimnagar District and 1st Appellate Authority / O/o the Revenue Divisional Officer, Karimnagar Division, Karimnagar District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 27-05-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

I, MD Feroz Khan, S/O Mr. Dildar Khan, residing at House No.:- 1-4-460, Pamchamukhi Hanuman Colony, Kamareddy, Telangana-503111.

I want to know the following information about the Mallareddy pet Assigned/Government land details. I want to need the following information from Public Information Officer of Mandal Revenue Office Gambhiraopet, please provide the following information:-

Mallareddy pet assigned/Government land details with Survey numbers before 15 years and present. If government land registered on others name i.e., please kindly provide current owner details and Survey numbers, above mentioned information in Telugu language section 4(4) and with attested copies as per section.

Kindly issue me with detailed information regarding the same along with the certified copy of such documents.

Kindly provide me the details, under RTI act 2005
As per section 6(3) of the RTI Act 2005, In case, the requested information is held by another public authority, I request the PIO to transfer the application or part of it within FIVE days and immediately inform me about such transfer.

As per section 7(8) (iii) and 7(3) (ii) of the RTI Act 2005 I request the PIO to Inform me of the particulars of First Appellate Authority.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 14-09-2021 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal was taken on file and Notices issued to both the parties for hearing on 15-07-2022 at 10.30 A.M.

The case is called on 15-07-2022. The appellant is present and filed his affidavit stating that the PIO has furnished part information. Sri T. Satyanarayana, Typist is present on behalf of the PIO / Sri G. Venu, Deputy Tahsildar, Gambhiraopet Mandal, Karimnagar District and filed his affidavit stating that the information was furnished to the appellant vide letter No: C/975/2022 dated: 06-07-2022. The representative of the PIO filed copy of the same before the Commission.

Heard both the parties and perused the material papers available on record. The appellant stated that the PIO has not furnished the attested copies of the information.

The Commission directs the PIO to furnish the information once again to the appellant duly attesting within One (1) Week from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.
