Order

Sri Sh. Polisetty Balakkrishna, Wanaparthy District has filed 2nd appeal dated: 14-12-2021 which was received by this Commission on 21-12-2021 for not getting the information sought by him from the PIO / Chief Administrative Officer, O/o the IX Addl. District Court, Wanaparthy District and 1st Appellate Authority / O/o the Registrar General, High Court for the State of Telangana, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 22-05-2018 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

1. Is there any chance to express the opinion or produce written affidavit of any accused before the Hon'ble Judge give information.
2. Is there any choice for accused to collect the documents and certified copies form the court without advocate(Civil and Criminal cases) give the information.
3. What is the procedure to file the civil suits, PILs, 200 crpc, private complaints without advocate party inperson give the information.
4. Is there any chance to produce the civil and criminal suits in Telugu language give the information.
5. Give the information about RTI Act. Section 4, 4(I), (B) 17 particulars from your office.
6. Your office appellate authority name and address, mobile number.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 04-07-2018 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal was taken on file and Notices issued to both the parties for hearing on 14-07-2022 at 10.30 A.M.

The case is called on 14-07-2022. The appellant is absent. The PIO / Chief Administrative Officer, IX Additional District Court, Wanaparthy District is absent.

Sri G. Naresh representative of Sri A. Kranthi Kumar Reddy, Advocate and Standing Counsel for the PIO / O/o the Registrar Judicial, High Court for the State of Telangana, Hyderabad is present and filed his affidavit stating that reply was given by the PIO to the appellant vide letter Dis. No: 932/2018/Admn/Genl dated: 25-06-2018 and an order was issued vide Appeal No: 122 of 2018 dated: 31-07-2018 upholding the reply of the PIO. The representative of the PIO filed copies of the same before the Commission.

Perused the material papers available on record. The Commission upholds the reply of the PIO and also the First Appellate Authority.

In view of the above, the appeal is closed.
