## **Order**

Sri Md. Ahasanuddin, Nalgonda District has filed 2<sup>nd</sup> appeal dated: 20-12-2021 which was received by this Commission on 22-12-2021 for not getting the information sought by him from the PIO / O/o the Legal Metrology Department, 209 PWD, Building, Gandhi Nagar, Hyderabad and 1<sup>st</sup> Appellate Authority / O/o the Legal Metrology Department, 209 PWD, Building, Gandhi Nagar, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 30-09-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

- 1) Please furnish Late Shaik Mahaboob's family pension particulars.
- 2) Please furnish all my applications which I have applied for compassionate appointment since 01-01-2002 to till date.
- 3) How many Compassionate appointments were considered in LM Dept, since 01-01-2002 to till date please furnish detail list of the compassionate appointments.
- 4) Please furnish the tribunal court judgement copy of my compassionate appointment APAT, O.A.No 8144/2002 dated: 30-09-2002.
- 5) Please furnish impugned proceedings of the Controller Legal Metrology (W&M) issued through Memo dated:22-11-2000, submitted in tribunal court, by Legal Metrology dept in the case O.A.No.8144/2002 dated: 30-09-2002.
- 6) Please furnish the Counter file submitted in the tribunal court, by Legal Metrology dept, in the case O.A.No:8144/2002, Dated:30-09-2002.
- 7) Please furnish All Superintendents, Clerks, Manual Assistants, Attenders names and their duration period those who have worked in LM head office since 01-01-2002 to till date.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1<sup>st</sup> appeal dated: 09-11-2021 before the 1<sup>st</sup> Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1<sup>st</sup> Appellate Authority even after 30 days of filing his 1<sup>st</sup> appeal, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to take action against the PIO and 1<sup>st</sup> Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2<sup>nd</sup> appeal was taken on file and Notices issued to both the parties for hearing on 22-07-2022 at 10.30 A.M.

The case is called on 22-07-2022. The appellant is present and filed his affidavit stating that the PIO has not furnished the information. The PIO / Sri K. Siddhartha Kumar, Assistant Controller, O/o the Legal Metrology, PWD Building, Gandhinagar, Hyderabad is present and filed his affidavit stating that the information was furnished to the appellant vide letter No: 49/RTI/E2/2021 dated: 05-03-2022 and filed copy of the same along with the acknowledgment of the appellant before the Commission.

Heard both the parties and perused the material papers available on record and the Commission is of the view that the PIO has furnished the information to the appellant.

Since the information is furnished, the appeal is closed.
