## **Order**

Sri T. Mahender Goud, Nizamabad District has filed 2<sup>nd</sup> appeal dated: 24-12-2021 which was received by this Commission on 28-12-2021 for not getting the information sought by him from the PIO / O/o the Survey and Land Records, Nizamabad District and 1<sup>st</sup> Appellate Authority / O/o the Survey and Land Records, Nizamabad District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 02-03-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

- ① కలనగిట్ల గ్రామ రెవెన్యూ పటం మరియు ఇవ్వగలరు (బట్టమర్చి) సేజీ.
- ② కలనగిట్ల గ్రామనికి చెందిన ఖాసా పహాసిల ఇవ్వగలరు (ఖాసా పహాసి).
- ③ కలనగిట్ల గ్రామంలో "అసైన్ మెంట్" చూపుట వివరాలు, విస్తీర్ణం? పట్టణం వారి వివరాలు తెలుపగలరు.
- ④ కలనగిట్ల గ్రామనికి సంబంధించిన ఎన్నికల - కిరుపులు కలవు? ఈయన చెరువుల - విస్తీర్ణం వివరాలు తెలుపగలరు.

The PIO / O/o the Survey and Land Records, Nizamabad District vide Lr. No. RTI/1734/2021, dated. 01-04-2021 transferred an application U/s 6(3) of the RTI Act to O/o the Tahsildar, Jakranpally Mandal, Nizamabad District with a request to furnish the information to the appellant.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1<sup>st</sup> appeal dated: 25-03-2021 before the 1<sup>st</sup> Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1<sup>st</sup> Appellate Authority even after 30 days of filing his 1<sup>st</sup> appeal, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to take action against the PIO and 1<sup>st</sup> Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2<sup>nd</sup> appeal was taken on file and Notices issued to both the parties for hearing on 06-07-2022 at 10.30 A.M.

The case is called on 06-07-2022. The appellant is absent. The PIO – I / Sri P. Shyam Sunder Reddy, Assistant Director, O/o the Survey and Land Records, Nizambad District is present and filed his affidavit stating that reply was given to the appellant vide letter Dis. No: A2/397/2021 dated: 09-03-2021 informing to approach the PIO / Assistant Director, Central Survey Office, Narayanguda, Hyderabad for point No: 1 and for point No: 2 to 4 the appellant was requested to approach the PIO / O/o the Tahsildar, Jakranpally Mandal, Nizambad District. The PIO filed copy of the reply before the Commission.

The APIO / Sri T. Gopal, Senior Assistant is present on behalf of the PIO – II / Sri B. Praveen Kumar, Deputy Tahsildar, Jakranpally Mandal, Nizambad District and filed his affidavit stating that reply for point No: 2, 3 & 4 was given to the appellant vide letter No: B/485/2022 dated: 30-06-2022 and for point No: 1 the appellant was requested to approach the PIO / Assistant Director, O/o the Survey and Land Records, Nizambad District.

Perused the material papers available on record and observed that the appellant through his 6(1) application dated: 02-03-2021 seeking information on 4 points relating to Kaligate Village and the PIOs furnished the available information and for point No: 1 the appellant was requested to approach the PIO / Assistant Director, Central Survey Office, Narayanguda, Hyderabad.

The Commission advise the appellant to file a separate application before the PIO / Assistant Director, Central Survey Office, Narayanguda, Hyderabad with a request to furnish the information.

In view of the above, the appeal is closed.
