Order

Sri Ghanshyam Das Soni, Sirpur-Kagaznagar has filed 2nd appeal dated: 24-12-2021 which was received by this Commission on 28-12-2021 for not getting the information sought by him from the PIO / O/o the Municipal Commissioner, Kagaznagar Municipality, Komarambheem District and 1st Appellate Authority / O/o the Municipal Commissioner, Kagaznagar Municipality, Komarambheem District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 28-08-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

With reference to subject mentioned herein above, I request your good self to please provide me the copy of report submitted to the Hon'ble Collector, K B District, Asifabad in reply to their letter RC No. D1/483/2021 dt 06 08 2021 and if no report is submitted by this time, then reason for not sending your report along with original fileNo. ROR/BIBRA/X-A/7/89 and also Pahani copies since 1985 till date.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 15-11-2021 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal was taken on file and Notices issued to both the parties for hearing on 06-07-2022 at 10.30 A.M.

The case is called on 06-07-2022. The appellant is absent. The APIO / Sri K. Bapu, Revenue Officer, O/o the Municipal Commissioner, Kagaznagar Municipality, Komaram Bheem Asifabad District is present and filed his affidavit stating that vide letter No: RTI/92/2021 dated: 05-11-2021 part information was furnished to the appellant for point No: 2 & 3 and vide letter No: RTI/73/2021 dated: 04-07-2022 the information for point No: 4 & 5 was furnished and the information for point No: 1 was furnished vide letter No: RTI/36/2022 dated: 05-07-2022. The APIO filed copy of the letters before the Commission.

Heard the APIO and perused the material papers available on record and observed that the PIO has furnished the information to the appellant.

Since the information is furnished, the appeal is closed.
