Order

Sri Dheeraj Bhoumik, Komarambheem District has filed 2nd appeal dated: 23-12-2021 which was received by this Commission on 28-12-2021 for not getting the information sought by him from the PIO / O/o the Tahsildar, Kagaznagar Mandal, Komarambheem Asifabad District and 1st Appellate Authority / O/o the Revenue Divisional Officer, Kagaznagar Division, Komarambheem Asifabad District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 03-09-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

Muzual wagr I am to inform you that I am an Advocate of the land client, survey no survey No: 23/428 village no-12, extend 0.68 & 23/429, 2.75 Acers and cultivating since 2000, kindly furnish the following information as per RTI Act.

1. Copy of 1B, copy of Pahani from 2000 to as on date ✓ *form-2*
2. R.O.R copys of in the year 2000 to till date.
3. Register 1 (A) & 1 (B) Extracts.
4. Market Value Certificate.
5. Selwar/Supplementary Sethwar/Wasool Baqui.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 16-11-2021 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal was taken on file and Notices issued to both the parties for hearing on 06-07-2022 at 10.30 A.M.

The case is called on 06-07-2022. The appellant is present and filed his affidavit stating that the PIO has not furnished the information. The APIO / Ms. D. Jayalaxmi, Senior Assistant, O/o the Tahsildar, Kagaznagar Mandal, Komaram Bheem Asifabad District is present and filed her affidavit stating that point wise reply was given to the appellant vide letter No: A/RTI/2021-56 dated: 05-07-2022 and filed copy of the same along with the postal receipt before the Commission.

Heard both the parties and perused the material papers available on record and observed that appellant filed 6(1) dated: 03-09-2021 seeking information on 5 points and the PIO replied to the appellant on 05-07-2022.

The Commission directs the PIO to allow the appellant for verification of records on a mutually fixed date and time by giving a prior intimation to the appellant and furnish the required information to the appellant as sought through his 6(1) application dated: 03-09-2021. This process should be complete within Two (2) weeks from the date of receipt of this order and report compliance to the Commission.

With the above direction, the appeal is closed.

The Commission directs to issue **Show Cause Notice** to the present PIO and the then PIO / Sri Jadhav Vishnu, Deputy Tahsildar, Kagaznagar Mandal, Komaram Bheem Asifabad District for not furnishing the information to the appellant within the stipulated period of 30 days as per Section 7(1) of RTI Act 2005. The action on the **Show Cause Notice** will be dealt separately.
