## Order

Sri B. Srinivas, Narayanpet District has filed a Complaint dated: 23-12-2021 which was received by this Commission on 28-12-2021 for not getting the information sought by him from the PIO / O/o the District Collector, Narayanpet Collectorate, Narayanpet District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 25-10-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

The PIO / O/o the District Collector, Narayanpet Collectorate, Narayanpet District vide Lr. No. H3/RTI/1525/2021 dated. 26-10-2021 transferred an application U/s 6(3) of the RTI Act to O/o the Tahsildar, Damargida Mandal, Narayanpet District with a request to furnish the information to the Complainant.

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint was taken on file and Notices issued to both the parties for hearing on 06-07-2022 at 10.30 A.M.

The case is called on 06-07-2022. The complainant is absent. The PIO / Sri Ch. Ravi, Deputy Tahsildar, Damaragidda Mandal, Narayanpet District is present and filed his affidavit stating that reply was given to the complainant by hand vide letter No: B/RTI/2021 dated: 23-11-2021 and filed copy of the same before the Commission.

Heard the PIO and perused the material papers available on record. The Commission is of the view that instead of informing that the information does not pertain to their office, the PIO ought to have informed from which Public Authority the information can be obtained. The Commission warns the PIO not to repeat such lapses in future and strictly adhere to the provisions of the RTI Act 2005.

The Commission directs the PIO to give specific reply point wise reply to the complainant within One (1) Week from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the complaint is closed.
