Order

Sri K.S.S. Ayyubi, Hyderabad has filed 2nd appeal dated: 29-12-2021 which was received by this Commission on 29-12-2021 for not getting the information sought by him from the PIO / O/o the Sub-Registrar, Banswada Mandal, Kamareddy District and 1st Appellate Authority / O/o the District Registrar, Kamareddy District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 18-09-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

- 1) Kindly furnish the copies of Registered Documents done in year 1978 to 1985 in survey No 134/1,134/2,134/3 of Tadkol Village Banswada Mandal Kamareddy dist.**

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 22-10-2021 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal was taken on file and Notices issued to both the parties for hearing on 15-07-2022 at 10.30 A.M.

The case is called on 15-07-2022. The appellant is present and filed his affidavit stating that the PIO has not furnished the information. The PIO / Sri AR. Swamy Das, Sub Registrar I/c, Banswada Mandal, Kamareddy District is present and stated that the appellant is seeking the registered documents done in the year 1978 to 1985 in Sy. No: 134/1, 134/2,134/3 of Tadkol Village, Banswada Mandal, Kamareddy District which is 44 years old record and the same can be obtained from Mee-Seva after paying the requisite fee.

Heard both the parties and perused the material papers available on record. The PIO submitted that a thorough search was made and the information is brought to the Commission and the same is furnished to the appellant before the Commission under acknowledgement of the appellant.

The Commission took a serious view against the PIO for not furnishing the information to the complainant within the stipulated period of 30 days as per Section 7(1) of the RTI Act 2005. The Commission warns the PIO not to repeat such lapses in future and strictly adhere to the provisions of the RTI Act 2005.

Since the information is furnished, the appeal is closed.
