Order

Sri RamMohan Thota, Hyderabad has filed 2nd appeal dated: 27-12-2021 which was received by this Commission on 29-12-2021 for not getting the information sought by him from the PIO / O/o the Child Welfare Committee, Child Protection Bhavan, H. No. 2-10-1799, Bhagya Nagar Colony, Opp. Andhra Bank, St. John's Branch Lane, Karimnagar District and 1st Appellate Authority / O/o the Child Welfare Committee, Child Protection Bhavan, H. No. 2-10-1799, Bhagya Nagar Colony, Opp. Andhra Bank, St. John's Branch Lane, Karimnagar District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 10-06-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

3. Details of Information

Please provide the following information u/s 2(f), (i), (j) and 6(1) of the RTI Act 2005:

Please provide me the certified copies of following, 1) Compliant, 2) Respondents Reply and 3) Final Report / Orders with office seal on each document. Photocopy of the compliant enclosed for reference.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 27-07-2021 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal was taken on file and Notices issued to both the parties for hearing on 15-07-2022 at 10.30 A.M.

The case is called on 15-07-2022. The appellant is present and filed his affidavit stating that the PIO has not furnished the information. The APIO / Sri R. Srinivas, Superintendent is present on behalf of the PIO / Smt. V. Padmavathi, District Welfare Officer, WCD & SC, Karimnagar District and filed her affidavit stating that the information was furnished to the appellant vide letter No: 39/CWC/KNR dated: 05-08-2021 and filed copy of the information furnished before the Commission.

Heard both the parties and perused the material paper available on record. The APIO furnished copy of the information to the appellant before the Commission under acknowledgement of the appellant.

Since the information is furnished, the appeal is closed.
