Order

Sri Shaik Zafar, Nizamabad District has filed a Complaint dated 27-12-2021 which was received by this Commission on 29-12-2021 for not getting the information sought by him from the PIO-I / O/o the Municipal Commissioner, Nizamabad Municipal Corporation, Nizamabad District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 09-12-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint was taken on file and Notices issued to both the parties for hearing on 15-07-2022 at 10.30 A.M.

The case is called on 15-07-2022. The appellant is absent. The PIO – I / Sri A. Karunakar, Town Planning Officer, O/o the Nizamabad Municipal Corporation, Nizamabad District is present and filed his affidavit stating that vide letter No: TP/TMS/PIO/281/2021 dated: 10-01-2022 the appellant was requested to pay Rs. 160/- for Xerox charges of 80 pages for point No: 4 & 5 and for point No: 8 since it is hypothetical no answer was given.

Sri B. Anand Sagar, Deputy Executive Engineer, O/o the Nizambad Municipal Corporation, Nizambad District is absent but filed his affidavit stating that vide letter No: ME/PIO/281/2021 dated: 22-12-2021 the application was transferred u/s 6(3) of RTI Act 2005 to the PIO / O/o the Executive Engineer, R&B Division, Nizambad District with a request to furnish the information to the appellant.

The APIO - II / Sri M.A. Quadeer, Superintendent, O/o the Executive Engineer, R&B Division, Nizambad District is present and filed his affidavit stating that point wise information was furnished to the appellant vide letter No: Supdt/NZBD/RTI Act 2005/2021-22/1798 dated: 17-02-2022 and filed copies of the same before the Commission.

Heard the PIOs and perused the material papers available on record. The Commission is of the view that the PIO has furnished the information to the appellant.

Since the information is furnished, the appeal is closed.
