Order

Sri Jangili Satyam, Jagitial District has filed a Complaint dated: 03-01-2022 which was received by this Commission on 07-02-2022 for not getting the information sought by him from the PIO / O/o the District Civil Supply Officer, Karimnagar District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 10-06-2020 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

2] గంగాధర మండలంలో గల విల్లి మహాలక్ష్మి తప్పి చేసినాడు, ఎప్పుడు తప్పిచేసినారు. ప్రాతి సమగ్ర వివరాలు ఇవ్వగలరు. త్రి తప్పిచేసి మరణాలు ముఖ్యమైనవి ఏమి చట్టాలు తీసుకున్నారు. వాటి యింకా ప్రాతి సమగ్ర వివరాలు ఇవ్వగలరు.
3] గంగాధర మండల కేంద్రంలో గల మాధవ ఇంజనీరింగ్ కాలేజీ కు డిప్యూటీ డైరెక్టర్ ఏ.కె.ఎ. (6.0) కు కారణ క్రమం ఇచ్చినాడు. వాటి యింకా రికార్డు క్రమం ఇవ్వగలరు.

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint was taken on file and Notices issued to both the parties for hearing on 01-09-2022 at 10.30 A.M.

The case is called on 01-09-2022. The complainant is absent. The PIO / Sri K. Suresh Kumar, District Civil Supply Officer, Karimnagar District is present and filed his affidavit stating that reply was given to the complainant vide letter No: G1/33/2021 dated: 19-03-2021 by hand and filed copy of the reply along with the acknowledgement of the complainant before the Commission.

Heard the PIO and perused the material papers available on record. The Commission is of the view that the PIO has furnished the information to the complainant.

Since the information is furnished, the complaint is closed.
