Order

Sri Mohd Akram Uddin Khan, Hyderabad has filed a Complaint dated: 07-02-2022 which was received by this Commission on 08-02-2022 for not getting the information sought by him from the PIO / O/o the Deputy Commissioner, GHMC, Circle-10, Falaknuma, Hyderabad.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 05-12-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

1. Under the Municipal Door no. 19-2-533, FATEH DARWAZA, NEAR GANDHI STATUE BARADARI-2 W-B: 19-2 HOUSE: 19- 2-533 EXTENT: 111SQ.Yds. If GHMC approve for Floors, then Kindly provide how many Floors permission is approved by GHMC.
2. Kindly let me know the new proposed construction plan is approved by GHMC under the Municipal door no. 19-2-533. If "YES", Then kindly provide us.
3. And also let us know the setback admeasuring area distance from the neighbor's house, according to the GHMC Act.

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint was taken on file and Notices issued to both the parties for hearing on 18-08-2022 at 12.00 P.M.

The case is called on 18-08-2022. The complainant is present and filed his affidavit stating that the PIO has not furnished the information. The APIO / Sri A. Ramdas, Assistant City Planner is present and filed affidavit of the PIO / Sri Ch. Rajender Reddy, Deputy Commissioner, GHMC, Circle – 10, Charminar Zone, Hyderabad stating that reply was given to the complainant vide letter No: RTI/60/ACP/C-10/GHMC/2021 dated: 24-11-2021 to furnish the file no and the permit no and on receipt of the Commission notice dated: 27-07-2022 vide letter No: RTI/275/ACP/C-10/GHMC/2022 dated: 10-08-2022 a reply was given to the complainant.

Heard both the parties and perused the material papers available on record.

The Commission directs the PIO to furnish the information to the complainant duly attesting within Two (2) weeks from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the complaint is closed.
