Order

Sri G. Manohar Reddy, Nizamabad District has filed a Complaint dated: 30-12-2021 which was received by this Commission on 04-01-2022 for not getting the information sought by him from the PIO / O/o the Tahsildar, North Mandal, Nizamabad District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 07-01-2022 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

Enquiry layout plans 15/2005,45/2005 dt.16.6.2006 released without Na a & purchase documents from land owners we need your inspection report of sy.no. 251/EE1 & 251/EE2 open enquiry report

1. My letter to Surpeme Court dt.3.8.2021 Inward No. 70784/SC/PIL(E) 2021
2. Letter dt 28.9.2021 of Ministry of Home Affairs, Govt. of India, New Delhi to me
3. Lr.No.TP/TMS/PIO/19/10/2021 dt.30.5.2021 of MUncipal Corporation to Me
4. No.PIO/IV/7495/2014 dt.20.9.2014 of Muncipal corporation, Nzb
- 5 My.No.GMR/NZB/894/2020 dt.9.7.2020 to you and other officials

Let me know what steps taken for the above three letters and inform me line wise and para wise about steps of three letters above. I need same for filing in the Court of law.

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint was taken on file and Notices issued to both the parties for hearing on 15-09-2022 at 10.30 A.M.

The case is called on 15-09-2022. The complainant is present and filed his affidavit stating that the PIO has not furnished the information. Sri Karthik Reddy, Deputy Tahsildar, Nizambad North Mandal, Nizambad District is absent.

Heard the complainant and perused the material papers available on record. The complainant stated that the PIO is wantonly and deliberately not furnishing the information.

The Commission directs the PIO to allow the appellant for verification of records on a mutually fixed date and time by giving a prior intimation to the complainant and furnish the required information or give point wise reply to the complainant as sought through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the complaint is closed.

The Commission directs to issue **Show Cause Notice** to the present PIO / Sri Karthik Reddy, Deputy Tahsildar, Nizambad North Mandal, Nizambad District and the then PIO / Sri M. Madhu, Deputy Tahsildar, Nizambad North Mandal, Nizambad District for not furnishing the information to the complainant within the stipulated period of 30 days as per section 7 (1) of the RTI Act 2005 and for appearing before the Commission for the hearing held on 15-09-2022. The action on the **Show Cause Notice** will be dealt separately.
