Order

Sri C. Praveen Kumar, Rangareddy District has filed a Complaint dated: 31-01-2022 which was received by this Commission on 10-02-2022 for not getting the information sought by him from the PIO / O/o the Tahsildar, Jadcherla Mandal, Mahabubnagar District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 12-11-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

I am The citizen of India. Please provide the following information under RTI act 2005.

- **provide the detail information of land survey no 167/1/1 and 156/2/2 of Udadapur village, Jadcherla Mdl, Mahaboobnagar Dist from 2006 to Nov 2021.**
- **If these land was taken by the government ,please provide the information of amount given to the land owner. if land owner didn't receive any amount from the government please provide the reason.**
- **If land owner received any amount, provide the bank details and date of amount issue**
- **The above survey Number lands are with any other names other than government. please provide the pass book details.**
- **If a person pay the amount for issuing Pattadar Passbook in Dharani portal. if that file was rejected by collector what is the process to return the amount.**

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint was taken on file and Notices issued to both the parties for hearing on 21-07-2022 at 10.30 A.M.

The case is called on 21-07-2022. The complainant is absent. The PIO / Smt. M. Venkateshwari, Deputy Tahsildar, Jadcherla Mandal, Mahabubnagar District is present and filed her affidavit stating that the information was kept ready and the complainant informed that he will personally visit his office and obtain the information, but since he did not come the same was not furnished.

Heard the PIO and perused the material papers available on record. The Commission took a serious view against the PIO for not furnishing the information to the complainant within the stipulated period of 30 days as per Section 7(1) of the RTI Act 2005. The Commission warns the PIO not to repeat such lapses in future and strictly adhere to the provisions of the RTI Act 2005.

The Commission directs the PIO to furnish the information or give point wise specific reply to the complainant duly attesting within One (1) Week from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the complaint is closed.
