Order

Sri Chapala Manohar, Nizamabad District has filed 2nd appeal dated: 09-02-2022 which was received by this Commission on 12-02-2022 for not getting the information sought by him from the PIO / O/o the Depot Manager, TSRTC, Bodhan Depot, Nizamabad District and 1st Appellate Authority / O/o the Managing Director, TSRTC, Musheerabad, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 13-12-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

- 1) 2019 డిసెంబర్ నుండి 2021 అక్టోబర్ వరకు ఎక్స్‌ట్రా బస్ బోధన్ నుండి నిజామాబాద్ వరకు 40.00 రూ. చార్జీ వసూలు చేసారు. కాని 2021 నవంబర్ నుండి 35.00 రూ. చార్జీ వసూలు చేస్తున్నారు. ఈ చార్జీ తగ్గించడానికి తమరు ఏ జీవ్ / నర్మలర్ ప్రకారం చేశారో తెలుపుతూ, అట్టి జీవ్ / నర్మలర్ మొత్తం ప్రతులు జిరాక్స్ చేసి ప్రతిపేజీ ధృవీకరించి ఇవ్వగలరు.
- 2) 2018 నుండి 2019 డిసెంబర్ వరకు బస్ పాస్ బోధన్ నుండి నిజామాబాద్ వరకు సాతది 760.00 రూ. 2019 డిసెంబర్ నుండి 2021 అక్టోబర్ వరకు 1020.00 రూ. వసూలు చేసినారు. 2021 నవంబర్ నుండి బస్ పాస్ 1220.00 వసూలు చేస్తున్నారు. ఈ బస్ పాస్ చార్జీ పెంచడానికి తమరు ఏ జీవ్ / నర్మలర్ ప్రకారం చేశారో తెలుపుతూ అట్టి జీవ్ / నర్మలర్ మొత్తం ప్రతులు జిరాక్స్ చేసి ప్రతిపేజీ ధృవీకరించి ఇవ్వగలరు.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 23-12-2021 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal was taken on file and Notices issued to both the parties for hearing on 01-09-2022 at 10.30 A.M.

The case is called on 01-09-2022. The appellant is absent, but filed his affidavit stating that the PIO has furnished the information. Sri G. Ramesh, Junior Assistant (P) is present and filed affidavit of the PIO / Sri T. N. Swamy, Depot Manager, TSRTC Bodhan, Nizambad District stating that the information was furnished to the appellant vide letter No: Supt.RTI(2)/20-BDN dated: 24-01-2022 and filed copy of the letter along with the postal acknowledgement before the Commission.

Heard the PIO and perused the material papers available on record. The Commission is of the view that the PIO has furnished the information to the appellant.

Since the information is furnished, the appeal is closed.
