Order

Sri Chapala Manohar, Nizamabad District has filed 2nd appeal dated: 09-02-2022 which was received by this Commission on 12-02-2022 for not getting the information sought by him from the PIO / O/o the Depot Manager, TSRTC, Sangareddy Depot, Sangareddy District and 1st Appellate Authority / O/o the Depot Manager, TSRTC, Sangareddy Depot, Sangareddy District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 08-10-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

1) సంగారెడ్డి సుండి బోధన్ సుండి నిజామాబాద్ వరకు 25 కిలో మీటర్ల దూరమునకు ఎక్స్ప్రెస్కు పాతవార్డు (నిజామాబాద్ కొత్తబస్టాండ్) 25.00 వసూలు చేసినారు. ప్రస్తుతం పెంచిన చార్జీల ప్రకారం ఎంత వసూలు చేస్తున్నారో తెలుపగలరు. రాష్ట్ర ముఖ్యమంత్రి ఇతరుల ప్రకారం కిలులో మీటర్కు 0.20 సైసలు వసూలు చేయాలని ఉన్నది. మీరు కిలోమీటరుకు ఎన్ని సైసలు వసూలు చేస్తున్నారో తెలుపగలరు. మొత్తం కాపీలు జరకొచ్చేసి ప్రతిపేజీ ధృవీకరించి ఇవ్వగలరు.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 20-10-2021 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal was taken on file and Notices issued to both the parties for hearing on 01-09-2022 at 10.30 A.M.

The case is called on 01-09-2022. The appellant is absent, but filed his affidavit stating that the PIO has not furnished the information. The PIO / Smt. T.V.S. Prabhavathi, Deputy Superintendent is present and filed affidavit of the PIO / Sri E.V. Satyanarayana, Depot Manager, TSRTC Sanga Reddy Depot, Sanga Reddy District requesting to give time to furnish the information.

Heard the PIO and perused the material papers available on record and observed that the complainant filed 6(1) application dated: 08-10-2021 seeking certain information and the PIO failed to furnish the information to the appellant.

The Commission directs the PIO to furnish the information to the appellant duly attesting within One (1) Week from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.

The Commission directs to issue **Show Cause Notice** to the present PIO / Sri Sri E.V. Satyanarayana, Depot Manager, TSRTC Sanga Reddy Depot, Sanga Reddy District and the then PIO / Sri Nagabhushanam, Depot Manager, TSRTC Sanga Reddy Depot, Sanga Reddy District for not furnishing the information to the appellant within the stipulated period of 30 days as per section 7 (1) of the RTI Act 2005. The action on the **Show Cause Notice** will be dealt separately.
