Order

Sri Syed Yunus Pasha, Mancherial District has filed 2nd appeal dated: 31-12-2021 which was received by this Commission on 04-01-2022 for not getting the information sought by him from the PIO / O/o the Tahsildar, Mandamarri Mandal, Mancherial District and 1st Appellate Authority / O/o the Revenue Divisional Officer, Mancherial Division, Mancherial District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 28-07-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

i. subject matter of information required. Pahanes for the year belongs to Sy.No.619

ii. Period of information: *Required: For the year from 1954-55 to 2020-21*

iii. Description of Information: Pahani Copy - belongs to Sy.No.619 for the year 1954-55
1955-56 1956-57. 1957-58 1975-76 1976-77 . 1977-78. .
Pahani certified copies belonging to Sy. No. 619 and 619/i 619/2 619/3 619/4 for
theyear 1979-80 1985-86 2004-2005 2011-2012 2012-2013
2013-14 2015-16 2016-2017 2017-18 2018-19 2019-20 and
2020-21 - 46th

iv. Whether information is *required by* person: In person

v. *in case by post* (Register post or ordinary post). Register post

4) whether the applicant is *below* the poverty line :- No

Note:- please furnish the date of receipt of application and the date of issue of Pahani Certified copies along with file number.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 28-07-2021 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal was taken on file and Notices issued to both the parties for hearing on 21-07-2022 at 10.30 A.M.

The case is called on 21-07-2022. The appellant is absent. Sri B. Thirupathi, Junior Assistant is present and filed affidavit of the PIO / Ms. B. Swapna, Deputy Tahsildar, Mandamarri Mandal, Mancherial District stating that the information was furnished to the appellant vide letter No: RTI/34/2021 dated: 30-11-2021 by hand and on receipt of the Commission notice dated: 01-07-2022 the information was once again furnished to the appellant vide letter No: RTI/69/2022 dated: 19-07-2022 and filed copy of the letter before the Commission.

Sri. Dilesh, Senior Assistant is present and filed affidavit of Sri Dasari Venu, Revenue Divisional Officer, Mancherial Division & District stating that vide letter Rc. No: I/448/2021 dated: 23-11-2021 the appellant and the PIO was called for hearing on 02-12-2021 and filed copy of the same before the Commission.

Perused the material papers available on record. The Commission is of the view that the PIO has furnished the information to the appellant.

Since the information is furnished, the appeal is closed.
