Order

Sri B. Gangadhar Rao, Kamareddy District has filed a Complaint dated: 10-02-2022 which was received by this Commission on 14-02-2022 for not getting the information sought by him from the PIO / O/o the Municipal Commissioner, Kamareddy Municipality, Kamareddy District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 10-01-2022 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint was taken on file and Notices issued to both the parties for hearing on 17-08-2022 at 12.00 P.M.

The case is called on 17-08-2022. The representative of the complainant is present and filed his affidavit stating that the PIO has not furnished the information. The APIO / Sri P. Ravi Gopal Reddy, Revenue Officer is present and filed affidavit of the PIO / Sri L. Giridhar Kumar, Town Planning Officer, O/o the Municipal Commissioner, Kamareddy Municipality, Kamareddy District stating that vide letter No: PIO/G1/73/2022 dated: 16-08-2022 the information is brought to the Commission and is ready to be furnished to the complainant. The APIO filed copy of the letter before the Commission.

Heard both the parties and perused the material papers available on record. The APIO furnished complete information to the complainant before the Commission under acknowledgement of the complainant.

The Commission took a serious view against the PIO for not furnishing the information to the complainant within the stipulated period of 30 days as per Section 7(1) of the RTI Act 2005. The Commission warns the PIO not to repeat such lapses in future and strictly adhere to the provisions of the RTI Act 2005.

Since the information is furnished, the complaint is closed.
