Order

Sri Shaik Sumer Pasha, Adilabad District has filed 2nd appeal dated: 01-01-2022 which was received by this Commission on 04-01-2022 for not getting the information sought by him from the PIO / O/o the Tahsildar, Boath Mandal, Adilabad District and 1st Appellate Authority / O/o the Revenue Divisional Officer, Adilabad Division, Adilabad District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 08-09-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

కొవచ్చిన సమాచారం పై

1) ఆర్డర్ గ్రామ పంచాయితీ పరిధిలో ఎంత యభుత్వ భూమి ఉండే వారి వైశాల్యంతో నవో ఇచ్చగలరు .

2) యభుత్వ భూమి ఎక్కడ ఉండే వారి వివరాలు మరియు భూమి వినియోగంలో ఉంటే ఎంత వినియోగంలో ఉంది వారి వైశాల్యం, వినియోగంలో వారి ఖాళీ స్థలం ఎంత ఉండే వారి వైశాల్యం పొందుపరచగలరు .

3) ఆర్డర్ గ్రామ పంచాయితీ పరిధిలో ఉన్న ఖాళీ స్థలం ఎంత ఉండే వారి వైశాల్యం, ఎక్కడ ఉండే వారి సమాచారం ఇచ్చగలరు .

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 13-10-2021 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal was taken on file and Notices issued to both the parties for hearing on 18-08-2022 at 10.30 A.M.

The case is called on 18-08-2022. The appellant is absent. The PIO / Sri R. Prakash, Deputy Tahsildar, Boath Mandal, Adilabad District is present and filed his affidavit stating that the information was furnished to the appellant vide letter No: A/RTI/283/2021 dated: 07-10-2021 and on filing 1st appeal dated: 13-10-2021 the appellant was called for hearing vide letter Rc. No: A/RTI/283/2020 dated: 26-10-2021 to appear on 30-10-2021 and again on 15-11-2021 and order was passed on 16-11-2021 to approach the Panchayat Secretary, Boath and obtain the information. The PIO filed copies of the information before the Commission.

Heard the parties and perused the material papers available on record and observed that the appellant through his 2nd appeal dated: 01-01-2022 filed before the Commission stated that when he approached the Gram Panchayat Secretary for the information, the Panchayat Secretary suggested him to approach the Deputy Tahsildar, Boath Mandal, Adilabad District and obtain the information. The Commission is of the view that both the PIOs deliberately not furnishing the information sought by the appellant.

The Commission directs the PIO / Sri R. Prakash, Deputy Tahsildar, Boath Mandal, Adilabad District and the PIO / Panchayat Secretary, Boath Village & Mandal, Adilabad District to furnish the information to the appellant duly attesting within Two (2) Weeks from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.

The Commission directs to issue **Show Cause Notice** to the present PIO and the then PIO / Sri R. Prakash, Deputy Tahsildar, Boath Mandal, Adilabad District and the PIO / Panchayat Secretary, Boath Village & Mandal, Adilabad District for not furnishing the information to the appellant within the stipulated period. The action on the **Show Cause Notice** will be dealt separately.
