Order

Sri M. Anil Kumar Reddy, Karimnagar District has filed 2nd appeal dated: 31-12-2021 which was received by this Commission on 04-01-2022 for not getting the information sought by him from the PIO / Gram Panchayat Secretary, Reddipalli Village, Veenavanka Mandal, Karimnagar District and 1st Appellate Authority / O/o the Mandal Praja Parishad, Veenavanka Mandal, Karimnagar District

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 27-07-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

01-01-2022 నుండి 24-07-2021 వరకు వోణివంక మండలం లోని రెడ్డిపల్లి గ్రామం నుంచి వుట్టివు విధించు పేరిట్ (పెన్షన్) కోరకు దరఖాస్తు చేసినప్పటి వారి వివరాలను, దరఖాస్తు దారులకు అమోదించిన, ఆరస్కరించబడిన వారి వివరాలను ప్రాధాన్యతగా ఇవ్వగలరని కోరుచున్నాను.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 14-09-2021 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal was taken on file and Notices issued to both the parties for hearing on 26-08-2022 at 10.30 A.M.

The case is called on 26-08-2022. The appellant is present and filed his affidavit stating that the PIO has furnished part information. The PIO / Sri D. Veerapratap, Panchayat Secretary, Reddypalli Village, Veenavanka Mandal, Karimnagar District is present and filed his affidavit stating that available information was furnished to the appellant on 11-03-2022, but failed to file copy of the letter before the Commission.

Heard both the parties and perused the material papers available on record. Upon not filing the documentary evidence of furnishing the information to the appellant, the Commission cannot accept the submissions of the PIO.

The Commission directs the PIO to furnish the information to the appellant duly attesting within One (1) Week from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.
