## **Order**

Sri Kaluvala Pratap, Mancherial District has filed a Complaint dated: 10-02-2022 which was received by this Commission on 15-02-2022 for not getting the information sought by him from the PIO / O/o the Prohibition and Excise Department, Bellampalli Mandal, Mancherial District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 24-11-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

1) మంచెరియాల జిల్లా దిల్లంపల్లి మండలం కన్నాళ గ్రామ పంచాయతీలో 2005 లో లో గల తాటిచెట్ల సంఖ్యను తెలుపగలరు

2) అనగా తాటిచెట్ల సంఖ్య అధికారములో ఉన్న తాటిచెట్ల ప్రకారం 2005 లో ఎన్ని చెట్లు కలవు అప్పుడు అనగా 2021 లో ఎన్ని చెట్లు కలవు

3) ...తాటిచెట్ల సంఖ్య అధికారములో ఉన్న చెట్లు ఎవరైనా నరికి వేతారే లేదో తెలుపగలరు ..వేసు అధికార విషయాలను వారితో దృవీకరించి ఇవ్వగలరు

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint was taken on file and Notices issued to both the parties for hearing on 21-07-2022 at 10.30 A.M.

The case is called on 21-07-2022. The complainant is present and filed his affidavit stating that the PIO has not furnished the information. The PIO / Sri D. Deepak, Prohibition & Excise Inspector, Bellampalli Mandal, Mancherial District is present and filed his affidavit stating that the information was furnished to the complainant vide letter No: RTI/03/2021 dated: 24-12-2021 and filed copy of the same before the Commission.

Heard both the parties and perused the material papers available on record. The complainant stated that the PIO has not attested the copies of information furnished.

The Commission directs the PIO to furnish the information to the complainant duly attesting within One (1) Week from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the complaint is closed.
