Order

Sri Kiran Bathula, Suryapet District has filed 2nd appeal dated: 14-02-2022 which was received by this Commission on 15-02-2022 for not getting the information sought by him from the PIO / O/o the Registrar Judicial, High Court for the State of Telangana, Madina, Hyderabad and 1st Appellate Authority / O/o the Registrar Judicial, High Court for the State of Telangana, Madina, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: Nil before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

Respected Sir,

The High Court for the State of Telangana issued a notification vide Notification No. 2/2019-RC dt:31-07-2019 for direct recruitment for the posts of JUNIOR ASSISTANT In the Telangana Ministerial Judicial Service. For this CBT (Computer Based Test) has been conducted later on few members have been called for interview in the ratio of 1:3. Recently final selection list has been displayed in the official website of Telangana High court .But Interview , CBT test marks of members those who were attended for the interview are not provided/displayed even in the website. Hence I request you to provide separately Computer based Test marks and Interview Marks of all Individual Candidates those who were attended for Interview of Junior assistant post in the state of Telangana State Judicial Ministerial Service. Also provide candidate community , and selected category in the final selection list. Please note that to provide the CBT marks separately and Interview marks separately of every individual those who were attended the interview of Junior Assistant Post- If possible provide the list as Districts wise of TELANGANA STATE.

Thanking you sir,

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 24-11-2021 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal was taken on file and Notices issued to both the parties for hearing on 16-09-2022 at 10.30 A.M.

The case is called on 16-09-2022. The appellant is present and filed his affidavit stating that the PIO has not furnished the information. Sri G. Naresh is present representing Sri A. Kranthi Kumar Reddy, Standing Counsel for O/o the Registrar Judicial, High Court for the State of Telangana, Hyderabad and filed affidavit stating that vide letter ROC No: 397/PIO/JUDL/2021 dated: 25-10-2021 the appellant was informed that the information falls under third party as such cannot be furnished and on filing 1st appeal dated: 24-11-2021 notice was issued vide appeal No: 97/2021 dated: 20-12-2021 to make his submission on 07-01-2022 accordingly on 24-01-2022 the First Appellate Authority dismissed the appeal.

Perused the material papers available on record.

Keeping in view of the reply given by the PIO and the First Appellate Authority, the appeal is closed.
