Order

Sri Sabir Ahmed Khan, Mancherial District has filed 2nd appeal dated: 18-12-2021 which was received by this Commission on 04-01-2022 for not getting the information sought by him from the PIO – I / O/o the Tahsildar, Naspur Mandal, Mancherial District, PIO – II / O/o the District Collector, Mancherial Collectorate, Mancherial District and 1st Appellate Authority / O/o the District Collector, Mancherial Collectorate, Mancherial District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 08-09-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

- ① furnish a copy of main affidavit filed by the petitioner in W.P. no. 1932/2020 (Relating to issue of N.40's plots allotted at Naspur by in s.no. 42) duly attested.
- ② furnish a copy of counter affidavit filed by the Respondent (Collector Mancherial) in W.P. no. 1932/2020 with attestation.
- ③ furnish a copy of reply counter affidavit filed by the petitioner in W.P. no. 1932/2020 with attestation.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 16-10-2021 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal was taken on file and Notices issued to both the parties for hearing on 21-07-2022 at 12.00 P.M.

The case is called on 21-07-2022. The appellant is present and filed his affidavit stating that the PIO has not furnished the information. The PIO – I / Smt. K. Shravani, Deputy Tahsildar, Naspur Mandal, Mancherial District is present and filed her affidavit stating that the information was furnished to the appellant on 24-12-2021, but failed to submit the copy of information furnished to the appellant before the Commission.

Smt. M. Sherisha, Section Assistant is present on behalf of the PIO – II / Sri Madhusudan Naik, Additional Collector / District Revenue Officer (FAC), Mancherial District and filed affidavit stating that vide letter Rc. No: A2/RTI/4906/2021 dated: 14-09-2021 the application was transferred u/s 6(3) of RTI Act 2005 to the PIO / O/o the Tahsildar, Naspur Mandal, Mancherial District with a request to furnish the information to the appellant. The representative of the PIO filed copy of the same before the Commission.

Heard both the parties and perused the material papers available on record. The appellant stated that he is not in receipt of the complete information. The PIO stated that the complete information is ready to be furnish to the appellant and the same is furnished before the Commission under acknowledgement of the appellant.

Since the information is furnished, the appeal is closed.
