Order

Sri Syed Yunus Pasha, Mancherial District has filed 2nd appeal dated: 31-12-2021 which was received by this Commission on 04-01-2022 for not getting the information sought by him from the PIO / O/o the Tahsildar, Mandamarri Mandal, Mancherial District and 1st Appellate Authority / O/o the Revenue Divisional Officer, Mancherial Division, Mancherial District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 30-07-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

I. subject matter of information: *Pahanees Copy and kasra pahni Copy*

ii. Period to which information: *1954-55 1955-56 1996-97 2014-15 2020-21*

iii. Discription of information required: *Pahani Certified copy of Sy.No.70 of Ponnaram shivar of Mandamarri Mandal for the year 1954-55 1955-56 1996-97 2014-15 2019-20 2020-21*

Kasra Pahani certified copies pertaining to Sy.No.70 of Pannaram Shivar belongs to Syed Meer S/o Syed Jamal Pattadar for the year 1954-55.

iv. Whether the information required by post or inperson. *In person*

V. In case by post [Register post or Ordinary Post] *Register Post*

4) whether the applicant is below the poverty line: *No*

Place: *Pannaram*

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 18-10-2021 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal was taken on file and Notices issued to both the parties for hearing on 21-07-2022 at 10.30 A.M.

The case is called on 21-07-2022. The appellant is absent. Sri B. Thirupathi, Junior Assistant is present and filed affidavit of the PIO / Ms. B. Swapna, Deputy Tahsildar, Mandamarri Mandal, Mancherial District stating that the information was furnished to the appellant vide letter No: B/15/2022 dated: 08-04-2022 by hand and on receipt of the Commission notice dated: 01-07-2022 the information was once again furnished to the appellant vide letter No: RTI/69/2022 dated: 19-07-2022 and filed copy of the letter before the Commission.

Sri. Dilesh, Senior Assistant is present and filed affidavit of Sri Dasari Venu, Revenue Divisional Officer, Mancherial Division & District stating that vide letter Rc. No: I/445/2021 dated: 23-11-2021 the appellant and the PIO was called for hearing on 02-12-2021 and filed copy of the same before the Commission.

Perused the material papers available on record. The Commission took a serious view against the PIO for not furnishing the information to the appellant within the stipulated period of 30 days as per Section 7(1) of the RTI Act 2005. The Commission warns the PIO not to repeat such lapses in future and strictly adhere to the provisions of the RTI Act 2005.

Since the information is furnished, the appeal is closed.
