## Order

Sri P. Rama Prasad, Vishakapatnam has filed 2<sup>nd</sup> appeal dated: 31-12-2021 which was received by this Commission on 04-01-2022 for not getting the information sought by him from the PIO / O/o the Registrar Judicial, High Court for the State of Telangana, Madina, Hyderabad and 1<sup>st</sup> Appellate Authority / O/o the Registrar General, High Court for the State of Telangana, Madina, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 20-01-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

Respected Sir / Madam,

పై సూచికలో పేర్కొనబడిన ఫిర్యాదుపత్రం దరిమిలా, గైకొనబడిన చర్యల సమాచారంను తెలియపర్చు పత్రంల ప్రతులను, R.T.I. Act, Section 2 (j) (ii) ప్రకారం ధృవీకరించి, యివ్వవలసిందిగా కోరుచున్నాను.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1<sup>st</sup> appeal dated: 22-04-2021 before the 1<sup>st</sup> Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1<sup>st</sup> Appellate Authority even after 30 days of filing his 1<sup>st</sup> appeal, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to take action against the PIO and 1<sup>st</sup> Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2<sup>nd</sup> appeal was taken on file and Notices issued to both the parties for hearing on 16-09-2022 at 10.30 A.M.

The case is called on 16-09-2022. The appellant is absent. Sri G. Naresh is present representing Sri A. Kranthi Kumar Reddy, Standing Counsel for O/o the Registrar Judicial, High Court for the State of Telangana, Hyderabad and filed affidavit stating that vide letter ROC No: 34/PIO/JUDL/2021 dated: 28-01-2021 the application was transferred U/s 6(3) of the RTI Act 2005 to the PIO / Administrative Officer, Ranga Reddy District Court Complex, at L.B. Nagar, Hyderabad with a request to furnish the information to the appellant and the PIO / Administrative Officer, Ranga Reddy District Court Complex, at L.B. Nagar, Hyderabad replied to the appellant vide letter Dis. No: 1469/RTI/2021 dated: 09-03-2021.

Perused the material papers available on record. The representative of the APIO submitted that the First Appellate Authority up helded the reply of the PIO.

Keeping in view of the reply given by the PIO and the First Appellate Authority, the appeal is closed.
