Order

Sri Vemula Pramod Reddy, Nizamabad District has filed 2nd appeal dated: 14-02-2022 which was received by this Commission on 18-02-2022 for not getting the information sought by him from the PIO / O/o the Sub-Registrar, Nizamabad Rural, Nizamabad District and 1st Appellate Authority / O/o the District Registrar, Registration & Stamp Department, Nizamabad District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 19-06-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

- 1] Document no 4558/2012 dated 20-4-2012 ఇట్టి Document దేని బధారంగా Registration అవుతుంది అట్టి కాఫీల కల చేయగలదు
- 2] Syno 178/3 extent 0.10 Guntas, Syno 178/6 extent 2.08 Acres, Syno. 178/7 extent 1-22 Acres ఇవ్వు Assignment భూములు అంటే దేనికి సంబంధిత Prohibition list కల చేయ గలదు.
- 3] Assignment భూములను Sale deed దేని బధారంగా చేశారు అట్టి కాఫీల కల చేయగలదు
- 4] ఇట్టి Document తేది 20-04-2012 లో ఎందుకు Registration కరెడు వానికి కరణం మరియు తేది 08/08/2012 లో ఏ కాఫీల బధారంగా తిరిగి Registration చేశారు. అట్టి కాఫీల కాఫీల కల చేయగలదు.
- 5] ఇట్టి Document no 4558/2012 లో ఉన్న Assignment భూములను ఏ Documents బధారంగా చేశారు Registration చేశారు.
- 6] ఇట్టి Document no 4558/2012 చెల్ల బలా అవుతుందా లేదా? జిరికే సంబంధించిన order లకు అనుగుణిత చేయ గలదు.
- 7] ఇట్టి Document no 4558/2012 క్రిస్టల్ చేయబడు గల Procedure కాఫీల కల చేయగలదు.

The PIO vide Lr. No. RTI/79/2021, dated. 19-07-2021 furnished the information to the appellant.

Aggrieved with the reply from the PIO, the appellant filed 1st appeal dated: 29-07-2021 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal was taken on file and Notices issued to both the parties for hearing on 15-09-2022 at 10.30 A.M.

The case is called on 15-09-2022. The appellant is absent, but informed over phone that the PIO has not furnished the required documents. The PIO / Sri M. Kiran Kumar, Sub-Registrar, Nizambad Rural, Nizambad District is present and filed his affidavit stating that reply was given to the appellant vide letter No: RTI/79/2021 dated: 19-07-2021 and again on 02-09-2021. The PIO filed copy of the same along with the postal receipt before the Commission.

Heard the PIO and perused the material papers available on record. The appellant through his 2nd appeal dated: 14-02-2022 stated that the PIO has not attested on the copies of the information furnished.

The Commission directs the PIO to furnish the information to the appellant duly attesting within One (1) Week from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.
