Order

Sri K. Dinesh Reddy, Hyderabad has filed a Complaint dated: 31-01-2022 which was received by this Commission on 18-02-2022 for not getting the information sought by him from the PIO / O/o the Deputy Commissioner, GHMC, Circle-11, Rajendernagar, Hyderabad.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 28-12-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

- 1) **Kindly furnish if the GHMC has accorded any permission for the subject building, if it has accorded permission then let me know under which Act of the GHMC building rules?**
- 2) **Kindly furnish the details of the building beside Andhra Bank, Pillar No. 134, Attapur, being renovated in the lower floors and additional two new floors being constructed viz GHMC sanctioned plan, GHMC Permit order/proceedings and PTIN numbers.**
- 3) **Please furnish the copies of the documents submitted by K. Ravinder Reddy & K.Bhaskar Reddy, Both S/o Late K. Kantha Reddy to obtain the building Permission for renovation/alteration/addition of additional floors of the building beside Andhra Bank, Pillar No. 134, Attapur.**
- 4) **If GHMC has not accorded the building permission then the construction carried out till date and ongoing construction is termed as legal or illegal ?**
- 5) **If it is Legal please furnish the details of the Act or Law under which it is Legal ?**
- 6) **If it is Illegal construction then please furnish the details of the action taken by the GHMC till date against the illegal constructions?**
- 7) **Whether any notices issued by the GHMC till date to the party in question for illegal construction , please furnish the copies of the Notices Issued by the GHMC?**
- 8) **Is the illegal construction work being carried out is stopped or not, if stopped please furnish the details and more few points.**

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint was taken on file and Notices issued to both the parties for hearing on 18-08-2022 at 12.00 P.M.

The case is called on 18-08-2022. The complainant is present and filed his affidavit stating that the PIO has furnished incomplete information. The APIO / Sri Mohd. Kabeerullah Khan, Town Planning Supervisor, O/o the Deputy Commissioner, GHMC, Circle – 11, Rajendernagar, Charminar Zone, Hyderabad is present and filed his affidavit stating that reply was given to the complainant vide letter No: 399/RTI/TPS/RJNR/C11/CRZ/GHMC/2021 dated: 25-02-2022 and information was furnished on 24-03-2022 by hand and filed copies of the information furnished along with the acknowledgement of the complainant before the Commission.

Heard both the parties and perused the material papers available on record.

The Commission directs the PIO to furnish the information for point No: 3 & 17 to the complainant (keeping in view of Section 8, 9, 10 & 11 of the RTI Act 2005) duly attesting within Two (2) weeks from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the complaint is closed.
