Order

Smt. Bhethi Bhimavva, Jagitial District has filed 2nd appeal dated: 15-02-2022 which was received by this Commission on 19-02-2022 for not getting the information sought by her from the PIO / O/o the District Civil Supply Officer, Jagitial District and 1st Appellate Authority / O/o the District Civil Supply Officer, Jagitial District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 15-09-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in her application:

వేది పేరు, గ్రామ పేరు, మండలం పేరు (D) చరఖ్కు చెరు
కొనిన తేదీ, నెల, సం॥ (E) గాన్జిల్ కనెక్షన్ పొందిన తేదీ, నెల, సం॥
(F) కనెక్షన్ నెంబర్, అందుకు అభ్యంతర కారణం "జాబితా"
నివేదిక చారిత్రా, "తెలుగు" నామక నామకం పంపించాలి.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 09-11-2021 before the 1st Appellate Authority requesting her to furnish the information sought by her u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing her 1st appeal, she preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by her and also to arrange to furnish the information sought by her u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal was taken on file and Notices issued to both the parties for hearing on 01-09-2022 at 10.30 A.M.

The case is called on 01-09-2022. The appellant is absent. Sri B.S.S. Vara Prasad, Deputy Tahsildar (Civil Supply) is present and filed affidavit of the PIO / Sri R. Rajiv Prem Kumar, District Civil Supply Officer, Jagtial District stating that reply was given to the appellant vide letter No: C/70/2021 dated: 14-12-2021 and filed copy of the reply along with the postal acknowledgement before the Commission.

Heard the representative of the PIO and perused the material papers available on record.

The Commission directs the PIO to give specific reply to the appellant duly attesting within One (1) Week from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.
