Order

Sri Togari Ushaloo, Karimnagar District has filed a Complaint dated: 14-02-2022 which was received by this Commission on 19-02-2022 for not getting the information sought by him from the PIO / O/o the District Panchayat Officer, Karimnagar District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 31-12-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

1) C.C. of R.O.CNO
A 3/903/96/PTS.
Dated: 29/3/1996.

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act.

In view of the above, the Complaint was taken on file and Notices issued to both the parties for hearing on 26-09-2022 at 12.00 P.M.

The case is called on 26-09-2022. The complainant is absent. The PIO / Sri Md. Fareeduddin, Administrative Officer, O/o the District Panchayat Office, Karimnagar District is present and filed his affidavit stating that reply was given to the complainant vide letter No: A1/RTI/2022-Pa dated: 10-01-2022 informing that the information sought is of more than 26 years old and is not available in their office. The PIO filed copy of the same before the Commission.

Heard the PIO and perused the material papers available on record. The Commission is of the view that the PIO ought to have informed as where the information sought would be available. The PIO submitted that the information would be available with the PIO / O/o the District Panchayat Office, Jagitial District.

The Commission directs the PIO / O/o the District Panchayat Office, Jagitial District and the PIO / O/o the District Panchayat Office, Karimnagar District to furnish the information to the complainant within Two (2) Weeks from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the complaint is closed.
