Order

Sri B. Gangadhar Rao, Kamareddy District has filed a Complaint dated: 16-02-2022 which was received by this Commission on 21-02-2022 for not getting the information sought by him from the PIO / O/o the Municipal Commissioner, Kamareddy Municipality, Kamareddy District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: Nil before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

4. సర్వే నెం. 4A, 4E లో ఇంటి నెం. 4-40, 4-50, 4-48, 4-49 అను మా ఇంట్ల యొక్క రే-అవుట్ చేయించ ఇవ్వగలరు.
5. సర్వే నెం. 4A, 4E లో ఇంటి నెం. 4-40, 4-50, 4-48, 4-49 ఇంట్ల యొక్క హద్దుల, ఇంటి నెంబర్లు, ఇంటి పన్నుదారుల పేర్లు ఏమిటి, ఇట్టి ఇంట్లు ఏ సంవత్సరంలో నిర్మించినారు ? సమాచారం ఇవ్వగలరు.
6. ఇంటి నెం. 4-40, 4-50, 4-48, 4-49 ఇంట్ల యొక్క పొడవు, వెడల్పు, ఎంత ? ఖాళీ భాగా కొలతలు చేయించ ఇవ్వగలరు.

and few more points.

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint was taken on file and Notices issued to both the parties for hearing on 17-08-2022 at 12.00 P.M.

The case is called on 17-08-2022. The representative of the complainant is present and filed his affidavit stating that the PIO has not furnished the information. The APIO / Sri P. Ravi Gopal Reddy, Revenue Officer is present and filed affidavit of the PIO / Sri L. Giridhar Kumar, Town Planning Officer, O/o the Municipal Commissioner, Kamareddy Municipality, Kamareddy District stating that part information was furnished to the complainant vide letter No: A1/71/2022 dated: 08-02-2022. The APIO filed copy of the information furnished before the Commission.

Heard both the parties and perused the material papers available on record. The APIO furnished complete information to the complainant before the Commission under acknowledgement of the complainant.

Since the information is furnished, the complaint is closed.
