## Order

Sri B. Parsharamulu, Karimnagar District has filed 2<sup>nd</sup> appeal dated: 21-02-2022 which was received by this Commission on 22-02-2022 for not getting the information sought by him from the PIO / Gram Panchayat Secretary, Metpally Village, Shankarapatnam Mandal, Karimnagar District and 1<sup>st</sup> Appellate Authority / O/o the Mandal Praja Development Officer, Shankarapatnam Mandal, Karimnagar District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 01-12-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

- 4) 2019 నుంచి 2021 వరకు గ్రామ సంఘాలకు మేజర్ గ్రాంట్ (MGB) ఓట్ల సూచి పంపించి సచివాలయం
- 2 నెలలు సూచి సచివాలయం పంపించినందుకు సూచి పంపించినందుకు సూచి పంపించినందుకు

Stating that the appellant did not receive the information from the PIO, the appellant filed 1<sup>st</sup> appeal dated: 20-01-2022 before the 1<sup>st</sup> Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1<sup>st</sup> Appellate Authority even after 30 days of filing his 1<sup>st</sup> appeal, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to take action against the PIO and 1<sup>st</sup> Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2<sup>nd</sup> appeal was taken on file and Notices issued to both the parties for hearing on 26-08-2022 at 10.30 A.M.

The case is called on 26-08-2022. The appellant is present and filed his affidavit stating that the PIO has furnished part information. The PIO / Sri L. Chavanlal, Panchayat Secretary, Metpally Village and the First Appellate Authority / Sri Md. Khaja Basheeruddin, Mandal Panchayat Officer, Shankarpatnam Mandal, Karimnagar District are present and filed their affidavits stating that vide letter No: GP/MTP/RTI/2021 dated: 28-12-2021 the appellant was requested to pay Rs. 1262/- for furnishing the information, but the appellant refused to accept the envelope and returned to the PIO. The PIO filed copy of the letter along with the postal receipt before the Commission.

Heard both the parties and perused the material papers available on record. The Commission upholds the reply of the PIO and advised the appellant to pay the requisite fee and obtain the information.

In view of the above, the appeal is closed.
