Order

Sri Rangu Rajender, Hanumakonda District has filed 2nd appeal dated: 21-02-2022 which was received by this Commission on 24-02-2022 for not getting the information sought by him from the PIO / O/o the District Welfare Officer, Women Development and Child Welfare Department, Hanumakonda, Warangal District and 1st Appellate Authority / O/o the District Welfare Officer, Women Development and Child Welfare Department, Hanumakonda, Warangal District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 27-12-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

The PIO vide Lr. No. A/RTI/2021-22, dated.10-01-2022 furnished the information to the appellant.

Aggrieved with the reply from the PIO, the appellant filed 1st appeal dated: 24-01-2022 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal was taken on file and Notices issued to both the parties for hearing on 25-08-2022 at 10.30 A.M.

The case is called on 25-08-2022. The appellant is absent. The PIO / Smt. M. Sabitha, District Welfare Officer, WCD & SC, Hanumakonda, Warangal District is present and filed her affidavit stating that the information is furnished to the appellant vide letter No: A/RTI/2021-22 dated: 10-01-2022 and filed copies of the information furnished along with the postal receipt before the Commission.

Heard the PIO and perused the material papers available on record. The Commission is of the view that the PIO has furnished the information to the appellant.

Since the information is furnished, the appeal is closed.
