Order

Sri V. Ramesh, Nalgonda District has filed a Complaint dated: 23-02-2022 which was received by this Commission on 25-02-2022 for not getting the information sought by him from the PIO / Deputy Executive Engineer, Road and Building Department, Miryalguda Mandal, Nalgonda District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 20-01-2022 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

అంశం : కలెక్షనల గురించి సమాచారం అందుకోవడానికి పట్టి (గ్రామం) అన్నింటినీ పంపించి తిమ్మలపల్లి X అడ్డు కలెక్షన్లు డిప్యూ యాజ్మీ పల్లి అసైండ్ సూపర్. 750 మాట్లకు పరిధి పురుషుల పేర్లు కలెక్షన్ ద్వారా కలెక్షన్లు అందజేసాలని.

యాజ్మీ పల్లి అసైండ్ సూపర్, తిమ్మలపల్లి X అడ్డు కలెక్షన్లు పరిధి పురుషుల పేర్లు కలెక్షన్ ద్వారా అందజేసాలని.

R.S.V రెస్ టబుల్, సూర్యరెస్ టబుల్ (త్రీవెయ్ రెస్ టబుల్) యాజ్మీ పల్లి అసైండ్ సూపర్. పురుషుల పేర్లు అందజేసాలని.

అంశం : రైల్వేలకు D.E, J.E, ఎడి - ఎయినాలు, ఇంజనీర్లు గురించి time-table వివరాలు తెలుసుకోవాలని.

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint was taken on file and Notices issued to both the parties for hearing on 17-08-2022 at 10.30 A.M.

The case is called on 17-08-2022. The complainant is present and filed his affidavit stating that the PIO has not furnished the information. The PIO / Sri K. Ganesh Kumar, Deputy Executive Engineer, R&B Department, Miryalguda Mandal, Nalgonda District is present and filed his affidavit stating that reply was given to the complainant by hand vide letter no: DEE/R&B/RTI/2021-22/197 dated: 19-01-2022 and filed copy of the same before the Commission.

Heard both the parties and perused the material papers available on record and observed that the complainant filed 6(1) application dated: 20-01-2022 seeking information on 4 points and as per the submissions of the PIO the reply was given on 19-01-2022 which is contrary. The Commission cannot accept the submission made by the PIO and warns the PIO not to repeat such lapses in future and strictly adhere to the provisions of the RTI Act 2005.

The Commission directs the PIO to give point wise specific reply and furnish the information to the complainant duly attesting within Two (2) Weeks from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the complaint is closed.
